

## Wage boosts and language improvments over life of 2-year agreement

- 2025 \$1.80/hour increase for all classifications equaling 2.9% up to 6.7% depending on classification
- 2026 Guaranteed 3% increase up to a maximum of 6% depending on average percentage change of Alberta CPI
- · More Job Steward roles
- 11.5 hrs straight time + 0.5 hrs overtime/day instead of 12 hours straight time for those working under the Hours Averaging Agreement
- 12% increase on the Hours Averaging Agreement Premium from \$3.60 to \$4.00
- 15% increase to the Night shift premium from \$3.00 to \$3.50
- · Addition of National Truth and Reconciliation Day as a named holiday
- · Reduction in the years of service required to earn more holiday time
- · Addition of Parts Journeypersons to the \$5,000/year Licensed Retention Bonus
- · New Un-Licensed Retention Bonus giving all un-licensed members a \$1,500/year bonus
- · Change of Sick Days to Paid Family Health and Wellness Days

# IUOE 955 RECEIVES SIGNIFICANT FUNDING FROM PATHWAYS ALLIANCE FOR CRUCIAL SKILLED TRADES TRAINING

EDMONTON – The International Union of Operating Engineers Local 955 received a sizeable investment from The Pathways Alliance - a collaboration between Canada's six largest oilsands producers - to ready more Operating Engineers to help the group meet its expanding labour needs.

The Pathways Alliance is a partnership between: Canadian Natural, Cenovus Energy, Conoco Phillips Canada, Imperial, MEG Energy and Suncor. The group works together to provide energy the world needs while advancing environmental innovation.

### CRANE BARGAINING BREAKS DOWN, LEGAL STRIKE VOTE COMING



Following close to 20 bargaining sessions and multiple dates of mediation, formal talks between IUOE 955's crane bargaining committee and the Alberta Crane Owners Association (ACOA) collapsed on Feb. 20 in Edmonton.

"Following time away from the table in January and early February for both parties to discuss the state of bargaining with their respective groups, we are incredibly disappointed to say the ACOA returned to the table with a reduced offer.

This is both unacceptable and disrespectful to the good and important work our crane members do, every single day," said IUOE 955 Business Manager, Chris Flett.

The actions of the ACOA have been beyond frustrating, but your committee remains dedicated to getting you the fair deal you deserve in a time of ever-rising costs.

Your continued resolve and solidarity are appreciated.

We have now entered a cooling off period, which ends on March 7.

Province-wide information meetings will be held:

Fort McMurray union hall – March 10 at 7:30pm Calgary union hall – March 11 at 7pm Edmonton union hall – March 12 at 7pm

At this point, please continue to go about doing the incredible work you do, every day.

### APPLY NOW! NB COUTTS SCHOLARSHIP AWARD - DEADLINE, AUG. 22

The NB Coutts Scholarship Award Program will begin May 1, 2025. All documents must be official transcripts by the post-secondary or high school the applicant last attended.

Scholarships may be awarded to students who are members or dependents of a member in good standing with the International Union of Operating Engineers Local 955.

### Eligibility Requirements:

- The total amount of each scholarship is \$5,000 to be paid over two consecutive years of academic study, in increments of \$2,500 per year. Recipients will receive \$2,500 in the first year and \$2,500 in the second consecutive year, while attending a full-time program at an accredited post-secondary institution.
- To be eligible for the scholarship, applicants must provide IUOE 955 with: the N.B. Coutts Scholarship Application form, official transcripts of the most recent year of study including proof of satisfactory academic standing (High School Grades or GPA Score), confirmation of enrolment and course load list for the subsequent year of studies.
- The minimum course load must be 80% of a "full course" load as defined by the institution and indicated on the course load transcript or confirmation of enrolment.

#### High School Applicants:

- High school transcript is required (core subjects are English, Math, Social Studies and one Science).
- Post-secondary transcripts including course load information.
- Second instalment requirements: Applicants will need to resubmit the N.B. Coutts Scholarship Application form, confirmation of enrolment transcripts, previous year's marks, and upcoming course load.

Deadline to apply is August 22nd, 2025.
